Background

- A. The parties listed in the Schedule to this deed (Existing Parties) are the current parties to the 'Collaboration Agreement for New Zealand's Biological Heritage National Science Challenge Ngã Koiora Tuku Iho' signed March-April 2015 (the NZBH Collaboration Agreement).
- B. The New Party wishes to become a party to the NZBH Collaboration Agreement.
- C. The New Party, the Existing Parties and the Ministry of Business, Innovation and Employment have each agreed for the New Party to be added as a party to the NZBH Collaboration Agreement on the terms set out in this deed.

This Deed records that
